### 8. REPORTS:

a. Road Report – Luke Serwe reported that Scott from Kafka has received all items for the plow truck box. Regular road maintenance was done all month. The loader backhoe was serviced and training was provided by John Deere. The Plow Truck was serviced and the sander has been put on. Signs were straightened, some sign posts were replaced. American Asphalt performed work in Edgewater, Luke provided grading to assist in the process. The blacktop was completed by American Asphalt. The salt and granite have been mixed for the season. The sweeping of the chip seal will be completed in Baywood Shores next week. Denny Meidl fixed the pot hole in front of Hotchkiss Bar.

Clerk Holcomb asked Luke Serwe to provide monthly report on work performed on Bob's Lane so that the work can be billed out.

b. **Fire Commission** – Dustin Skaya reported that Stratford Area Fire Department pulled water from Edgewater and not from the pond. There were multiple tankers there with water. The town was only charged by McMillan and Edgar due to the mutual aid agreement.

Clerk Holcomb to add fire costs to the annual meeting. There are several towns that are paying for the deductible and the homeowner pays the remainder of the costs with proceeds from the insurance company.

She further updated the board on the driveway permit for the town garbage collection, badger books for the elections, the elections commission computer grant, insurance renewal for 2020, 2020 scheduled elections, voting machine maintenance and the latest fire cost invoice.
