This spring and early summer has been somewhat challenging as far as roads and road maintenance is concerned. However, one only has to look at some of our neighbors to realize we have had a relatively easy time of it, so far, considering what other townships are enduring in terms of washouts and damage to roads.

Appropriation of funds is always something town boards have had to manage during the budget year and this year will be no different. We will soon be preparing our 2020 budget. Our plan is to purchase some needed equipment for our road supervisor to have available in good working order for proper road maintenance. Also, if you recall at the annual meeting held in April, we are planning to purchase a new truck for the town. This will position our township for the future with equipment to clear the roads efficiently during the winter months.

We appreciate the volunteers who came forward to participate on a committee to work on a long-range plan for our roads in the Town of Cleveland. Our township is changing and this means our roads will have different needs to meet increased traffic, which may include the need to blacktop roads. Town officials before us had many of the same trials to overcome and we paid our bills and kept up with current demands. The status quo is okay, but status quo does not secure a long-range plan. Special Notes

Please make sure all recycling items are in a clear bag. If using a black plastic bag, it will be put in the landfill and not recycled. Please do not include any sharp metal, batteries, diapers, needles, light bulbs, paper plates and cups, food, scrapwood, clothing and wine out of the recycling bin. These items should go in the regular garbage bins.

Please remember to keep tin and aluminum separate. There are bins for each of these items.

The town is currently considering options to dispose of road debris such as branches.

Roads Update

The road side brush has been cut. All culverts have been replaced with the exception of one which is in process. There was a culvert on Rock Road fixed. There were three culverts on Big Rapids Road worked on. All granite has been spread. We are currently working on maintenance in Baywood Shores and Edgewater subdivisions.

As a reminder, 25 mph is the speed limit for ATV's on Town roads.
